

## INSTALLATION INSTRUCTIONS

### HUSTLER MODELS SSM-1 & SSM-2 MOUNTS

#### CONVENTIONAL INSTALLATION

Use the cork grommet as a template and scribe the four (4) hole locations (center hole and three mounting holes). Drill the 1-5/16" center hole with a hole saw.

Use a 9/32" drill for the three mounting holes. Mount the base assembly according to the illustration.

#### INSTALLATION FOR RESTRICTED AREAS:

In very restricted areas, due to cross bracing, sub-paneling, etc., advantage may be taken of the horse shoe washer. Using the cork grommet as a template, locate and drill a 3/16" diameter hole for the 8-32 bolt in addition to the four holes required for a Conventional Installation. Dress the coax from inside the car out through the 1-5/16" hole. Adjust the pointed allen head screw, see illustration "C" until just the full point only protrudes from the horseshoe washer. With the aid of a lug, connect the braid of the coax under the 8-32 nut and tighten securely. Insert the horseshoe washer through the 1-5/16 hole and retain the assembly in place on the inside of the vehicle panel with the 8-32 horseshoe retaining screw.

With the gasket next to the ball mount, hold the mount close to its mounting location and attach the center lead to the ball connection. Dress the excess cable back into the vehicle avoiding any short circuit or sharp bends and position the mount over the correct holes for inserting and tightening the 1-3/8" mounting bolts.

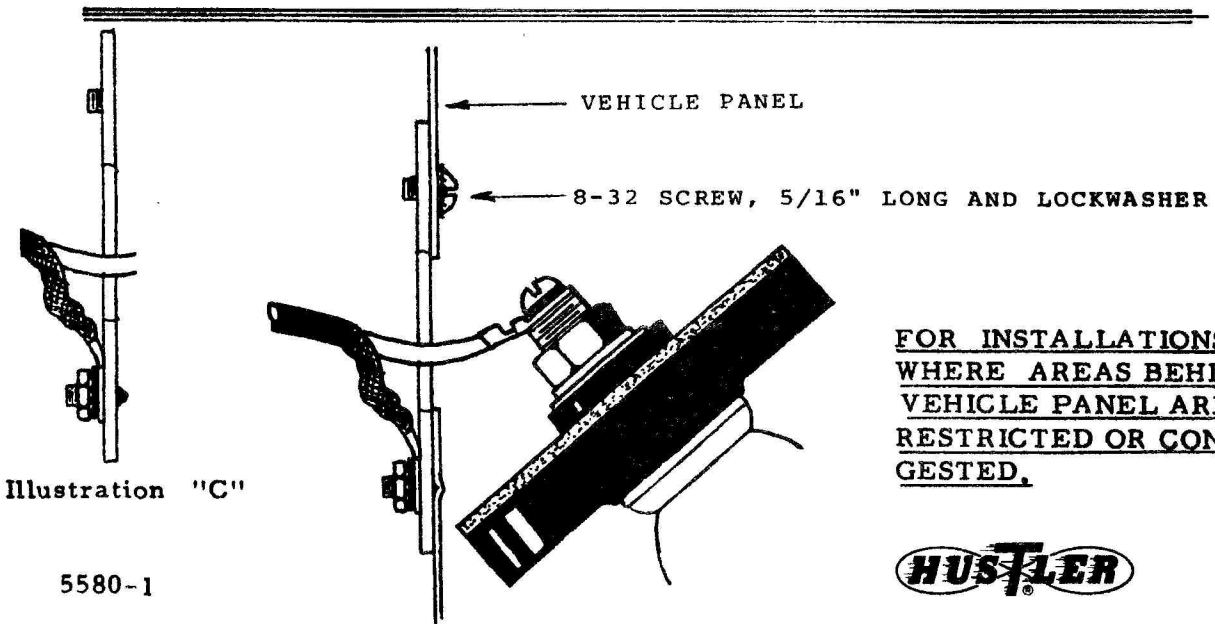
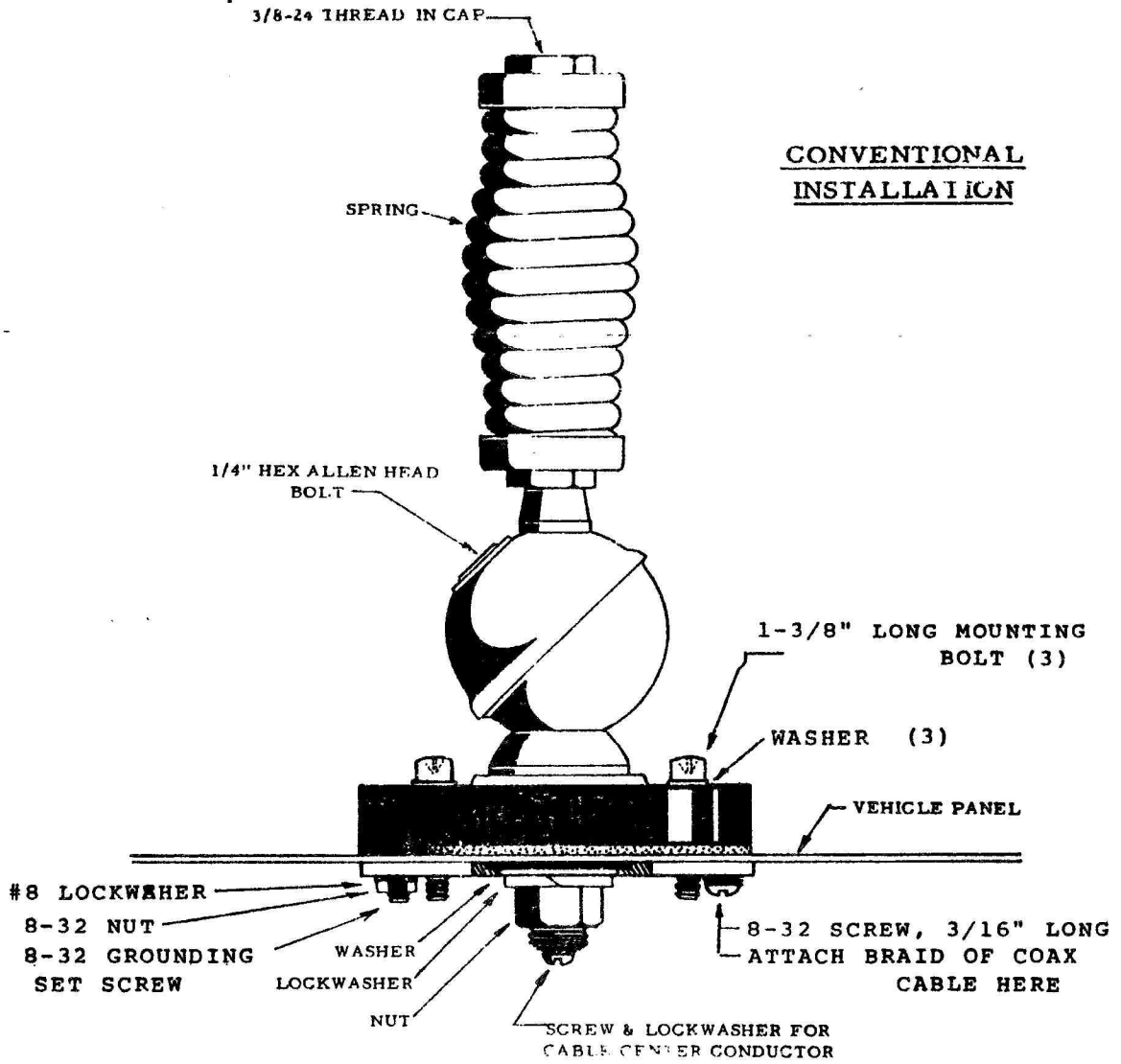
